REGULATORY UPDATES

Empowering women and transgender entrepreneur in food business through fast processing of license/ Registeration application

The FSSAI has created a provision in the online food safety compliance system(FoSCoS) portal to identify the persons of 'Special Category for faster processing of license/ Registration applications. This provision enables licensing and registering authorities to process such 'special category' applications in a 1:1 ratio with regular applications.





Inclusion of QR Code on Food Products for the accessibility of Visually Impaired Individuals

To enhance the accessibility to all consumers including Visually Impaired Individuals, Food Business organizations are encouraged to incorporate provisions that facilitate easy access to nutritional information for visually impaired individuals. One effective way to achieve this is by incorporating Quick Response (QR) codes into product labels.

Plastic Waste Management (Second Amendment) Rules, 2023

The Ministry of Environment, Forest and Climate Change (MoEFCC) has issued the Second Amendment in Plastic Waste Management Rules, 2023 which comes into force from the date of its official publication.





FSSAI Revised the option for selecting the validity period during application for FSSAI License/registration

FSSAI has issued a notification on 11-11-2023 which highlights that Food Business Operators applying for new license/registration or applying for renewal shall be able to select the validity period of 1 to 5 years in their applications with effect from 08th November 2023, with fee as applicable for the selected period as per Schedule 3 of FSS (Licensing and Registration of Food Businesses) Regulations, 2011.

FoSCoS becomes more user friendly with the introduction of web portals in regional languages

In a significant step towards further enhancing the user experience and accessibility, the Food Safety and Standards Authority of India (FSSAI) has launched the Food Safety Compliance System (FoSCoS) portal in multiple regional languages. The portal is now available in Gujarati, Tamil, Telugu, Marathi, apart from Hindi and English, with plans to launch the portal in Kannada, Punjabi, Malayalam, Assamese, Bengali and Odia soon. The latest advancement aims to enhance the user experience for local food businesses, allowing them to easily connect with the FSSAI's online compliance portal i.e FoSCoS.





Revocation of Suspension of M/s Megsan Labs Private Limited, Hyderabad, Telangana

In continuation to FSSAI Office Order of even number dated 31st Dec 2021, 13th July 2022, and 28 Aug 2023, the suspension of M/s Megsan Labs Private Limited, Hyderabad, Telangana (FSSAI Reg. No. 38/S/FSSAI/2016) is hereby revoked with immediate effect.





Suspension of Jubilant Pharma and Chemical Lab (OPC) Pvt. Ltd., Navi Mumbai


FSSAI has issued an order which highlights that FSSAI's recognition of the aforementioned laboratory by NABL, Jubilant Pharma and Chemical Lab (OPC) Pvt. Ltd. is hereby suspended w.e.f. 23rd October, 2023 from carrying out analysis of samples under the Food Safety and Standards Act, 2006 and Rules and Regulations made thereunder as per regulation clause 10 (2) read with clause 10(1) (iii) of the Food Safety and Standards (Recognition and Notification of Laboratories) Regulations, 2018 for a period of six months.

Application Fees for Vegan Logo Endorsement Applications as per Food Safety and Standards(Vegan Foods) Regulations, 2022

FSSAI has revised the application fees for the Vegan Logo Endorsement for applied products from Rs.25000/-(excluding GST) per product to Rs.10000/-(excluding GST) per application irrespective of the number of products.



Use of Steviol glycoside (stevia) in 'cocoa and chocolate products' and 'imitation chocolate'



FSSAI has issued a notification regarding use of Steviol glycoside (stevia) in 'Cocoa and Chocolate products' and imitation chocolate. At present "steviol glycoside (INS 960)' as an additive is not permitted for use in 'Cocoa and Chocolate products for use in 'Cocoa and Chocolate products' (FCS 5.1.3) and 'Imitation chocolate, chocolate substitute products' (FCS 5.1.4) as per extant FSS (Food Product Standards & Food Additives) Regulations, 2011. 'steviol glycoside' is permitted as an additive in other food categories such as Dairy-based drinks, Powder analogues, Dairy-based desserts, Edible ices, Canned or bottled (pasteurized) fruit, etc.

Direction to the registered Producers, Importers and Brand Owner (PIBOs) of F/Y 2022-2023 which have not filed Annual Report.

Central Pollution Control Board (CPCB) under the Ministry of Environment, Forest and Climate Change (MoEFCC) has issued a direction under section- 5 of the Environment (Protection) Act 1986 to registered Producers, Importers and Brand Owner (PIBOs) of F/Y 2022-2023 which have not filed Annual Report. The Annual Report for F/Y 2022-23 with the complete details shall be uploaded on the centralized Extended Producers Responsibility Portal for Plastic Packaging on or Before November 30, 2023. If Your unit fails to upload the Annual Report, Environmental Compensation shall be levied without any communication. Further action under the provision of the Environment (Protection) Act 1986 shall be initiated, as deemed appropriate, against violation of the direction.





Rectifiable labelling information for imported food consignments

FSSAI has issued an order on Rectifiable labeling information for imported food consignments, wherein FSSAI has decided that all the labeling deficiencies on imported food consignments may be permitted for rectification in the custom bonded warehouse, except the following:

- · Lot No. / Code No. / Batch identification
- Date Marking [Date of manufacture or packaging" and "Expiry/Use by/Best Before]
- Country of Origin for Imported Foods



The Label rectification has to be carried out at Customs bonded warehouses, before visual inspection or re-inspection by the Authorised Officer or his representative, by affixing a single non-detachable sticker or by any other non-detachable method.

Procedure for Reactivation of Auto-Rejected Licensing/Registration Application



FSSAI has issued an order in Procedure for Reactivation of Auto-Rejected Licensing/Registration Application due to non-response to the queries of the licensing/registration authority within the specified timeline. The provision for self-reactivation of auto-rejected applications shall be provided only once for any filed application for a new license/registration or modification of a license. Within 30 Days of auto-rejection of application: FBO is allowed to self-reactivate the application without any intervention of the authority and fee. During the period of the 31st to 60th day of auto-rejection of the application: In this case, FBO is allowed to self-reactivate the application without any intervention of the authority, subject to payment of fee as specified below as well as a valid reason for the delay:

- a) For Registration application: Rs. 50+ GST(as applicable)
- b) For License application: Rs. 500 + GST(as applicable)

Envionment Compensation for the late filing of Annual Report

The last date for filing of Annual Report by PIBOs registered during the year 2022-23 is November 30, 2023. By the provisions of EC Guidelines, all such PIBOs are hereby informed that they should file the Annual Report by December O5, 2023. EC of Rs.5000/- towards late filing of Annual Report shall be levied on those PIBOs who file their Report by December 10, 2023 and a late fee of Rs.10000/- shall be levied on those PIBOs who file it by December 20, 2023, following which Annual Report shall be autofiled, and EC, if any towards shortfall in fulfilling EPR Target along with the late of Rs.10000/-, shall be levied on the defaulters





NEWS BRIEF

CPCB orders 45 of 105 Maharashtra sugar units to shut down

The Central Pollution Control Board (CPCB) has ordered closure of 45 cooperative sugar factories in Maharashtra for blatant violation of the Environmental Protection Act. Maharashtra has a total of 190 sugar units, of which 105 are in operation. The sugarcane crushing season will begin from November 1. This is for the first time that such a large number of sugar units have been served with closure notice In a letter to Maharashtra Pollution Control Board

(MPCB).



UP government has banned Halal-certified food products

The Uttar Pradesh government, led by Yogi Adityanath, has bannedthe production, storage, distribution, and sale of food products with halal certification, effective immediately. However, products manufactured for export are exempted from this ban. The government claims that there have been "malicious attempts" to discourage the use of non-halal certified products, which not only seek unfair financial benefits but also form part of a larger strategy to sow class hatred, create divisions, and weak the country by anti-national elements



Edible oil industry body SEA urges government to hike duty difference between crude & refined palm oil

Edible oil industry body SEA has demanded that the government should increase the duty difference between crude and refined palm oil to 15 per cent from 7.5 per cent to curb imports of refined cooking oil and protect domestic players. In a letter to its members, Solvent Extractors' Association of India (SEA) President Ajay Jhunjhunwala pointed out that Indian vegetable oil (comprising of edible and non-edible oil) refining industry is "facing challenges".

In its 63rd council meeting, International Sugar Organisation (ISO), headquartered in London, has announced India to be the Chair of the organisation for 2024. This is a huge achievement for the country to lead the global sugar sector and reflection of growing stature of the country in this domain.
